211 is a free, confidential service offered statewide for people who need help. Last year, we connected the community with over 3,400 government, non-profit and human service agencies. We received over 28,000 calls, which resulted in over 35,000 referrals and our 211 website handled nearly 40,000 searches for help.

Get Connected/Gifts-in-Kind

Connecting the community with volunteer opportunities and connecting “gently used” items with non-profit organizations and the needy. Last year, we connected over 14,000 potential volunteers with non profits in our community.

C. COMMUNITY NEEDS

Education

Aloha United Way believes every child should have the chance to be healthy, loved, nurtured, safe and have access to quality childcare and early education. Our work includes programs that increase parenting skills, make available books to children and provide developmental screening for toddlers. We also fund programs to increase high school graduation rates.

Poverty Prevention

Aloha United Way prevents at risk families from becoming homeless and helps homeless families transition back into safe and stable housing. We also fund support programs that enhance employment skills and career opportunities for people with disabilities.

Safety Net

Helping families and individuals in crisis meet basic needs for food, clothing, medical care, safe shelter and emergency assistance, including aid in domestic violence or substance abuse situations.
